We don't hear enough about small-cap companies at the best of times, so the 2021 Small Cap Awards are a long overdue opportunity to celebrate their successes, not only navigating the difficult (often impossible) trading environment of the last 24 months, but also raising capital, doing deals, growing and innovating, and seeing the disruption as an opportunity to win market share from some of their slower, larger rivals.
